#### **ACTION REQUIRED - BILLING SOFTWARE & PAYMENT SCHEDULE CHANGES**

The Physician Payment Schedule revisions outlined in this letter are effective October 1, 2021.

As outlined in the physicians' Direct Payment Agreement, payment for services submitted to Medical Services Branch is made in accordance with the applicable Physician Payment Schedule in effect on the date the service is provided. It is imperative that your billing software is utilizing the most up-to-date rate file. The new October 1, 2021, rate file has been provided to all software vendors and is posted on the Internet Claims Submission (ICS) website for download. If necessary, please contact your software vendor, to apply the update to your application and ensure your claims are being paid appropriately and/or at the new rate.

#### **BILLING RESOURCES**

There are billing resources, such as billing information sheets, available on the website. These documents are provided to all new physicians upon registering with Medical Services Branch. They are also available for download or viewing at the above link.

#### **GENDER NEUTRALITY**

As part of Payment Schedule Modernization, changes have been made throughout the Physician Payment Schedule to incorporate gender-neutral language. These changes replace gender-specific pronouns with those that are not gender-specific (i.e. they/them).
