## **CHANGES TO THE PAYMENT SCHEDULE**

**The Physician Payment Schedule revisions outlined in this letter on page 3 are effective April 1, 2017.** Software vendors have been provided with the updated payment schedule. Please contact your vendor, if necessary to make sure they have updated your system to ensure your claims are being paid appropriately.

## PAPER COPIES OF THE PAYMENT SCHEDULE

Medical Services Branch does not provide paper copies of the Physician Payment Schedule. The Physicians' Newsletter and Operation's Bulletin will continue to be mailed out. Copies of the Payment Schedule can be found at the website link above.

# NEW PHYSICIANS REQUIRED TO BILL ELECTRONICALLY

All new physicians are required to submit their claims electronically to Medical Services Branch. Information on the options available to new physicians is provided when physicians are initially set up for billing purposes.



#### **ACTION REQUIRED – PHYSICIANS/CLINICS BILLING SOFTWARE**

As outlined in the Physician Direct Payment Agreement, payment for services submitted is made in accordance with the Physician Payment Schedule applicable to the service on the date provided. It is imperative that your billing software is utilizing the most up to date rate file. The new April 1, 2017, rate file has been provided to all software vendors and is posted on the Internet Claims Submission (ICS) website for download. Please contact your software vendor, if necessary, to apply the update to your application.

#### **PAYMENT SCHEDULE MODERNIZATION (PSM)**

As part of the recent SMA-Ministry Agreement, the two parties are proceeding with modernization of the Payment Schedule within the principles of patient-centered care, appropriateness, and fairness. As part of this project, 'outdated' codes with zero 2015-16 utilization were reviewed by physician sections.

PSM reviewed codes from the **Anesthesia** and **Cardiolog**y sections and determined that the payment code descriptors had been superseded in clinical practice by more effective and professionally accepted techniques and, thus, no longer considered the best treatment in the opinion of the profession. Therefore, these services have been removed from the Physician Payment Schedule. See Section H (Anesthesia) and Section I (Cardiology) for the specific codes that were deleted.

#### **"MEET-AND-GREET" VISITS**

As outlined in *The Saskatchewan Medical Care Insurance Act*, all services submitted to the Medical Services Branch for payment must be medically required. "Meet and greet" visits for the purposes of establishing a relationship with a new patient are not considered medically required and should not be billed to Medical Services Branch. The first contact with a new patient may occur at a visit which some refer to as a **meet-and-greet** visit wherein the physician may use this visit to identify the patient's needs and expectations, gather the patient's history, and disclose information about their practice. This service is listed on page 31 of the Physician Payment Schedule as uninsured. Please also refer to the College of Physicians and Surgeons of Saskatchewan guidelines, "Patient-Physician Relationship" for more information.

#### **ULTRASOUNDS FOR NON-MEDICAL REASONS**

As outlined in *The Saskatchewan Medical Care Insurance Act,* all services submitted to the Medical Services Branch for payment must be medically required. Obstetric ultrasounds for the provision of determining fetal gender, entertainment, maternal reassurance, fetal keepsakes, or portraits are not medically required and are not insured services. This service is listed on page 31 of the Physician Payment Schedule as uninsured. Please also refer to the College of Physicians and Surgeons of Saskatchewan policy, "Ultrasound for Non-Medical Reasons" for more information.
